LIMITED AKC REGISTRATION: The dog is sold as a limited registration pet and DOES NOT come with AKC breeding privileges. This dog shall be neutered/spayed within 6 months of purchase.

FULL AKC REGISTRATION: Open/Full registration puppies are offered to ***Pre-Approved homes ONLY.*** Full registrations will be accompanied by an additional "Non-Compete" agreement signed by both buyer and seller. Please note that not all Boxers should be bred. We are here to serve as ambassadors for our chosen breed and only breed the best to further improve the breed.

This dog is guaranteed to be in good health, to the best of our knowledge at the time of this sale, and has had initial inoculations against distemper, parvovirus, parainfluenza, and received de-worming. The buyer has **(3) three business days** from the day of delivery in which to have the dog checked by a licensed veterinarian, and is urged to do. If the veterinarian finds the dog to be seriously ill, the cause of which is clearly hereditary in nature (this does not include the presence of parasites), return the dog along with the AKC Registration papers. Another dog of similar breeding will be given in exchange, or money returned if no other dogs are available at that time, provided a letter from the examining veterinarian is offered as proof of illness. It is agreed and understood that any exchange must be made within the (3) three day guarantee period. The seller assumes no responsibility for this dog after leaving premises for medical expense (including veterinary exam), mortality, landlord's disapproval, allergic reaction to dog, disagreement with family, behavioral/training difficulties, mistreatment of dog, accidental poisoning or trauma to dog, re-growth of dewclaws or for any other reason.

It is further understood and agreed that no warranty or representation has been made with respect to sold dog, except as set forth in writing in this agreement. This guarantee is valid only for the original owner and is non-transferable.

****FAILURE TO HAVE YOUR PUPPY CHECKED BY A VETERINARIAN WITHIN THE REQUIRED TIME PERIOD OF THREE (3) BUSINESS DAYS OF DELIVERY, VOIDS ALL WARRANTIES.****
